A reliable source information has been received that certain public officials associated with the Ministry of Health and Family Welfare, Government of India, New Delhi, and the National Medical Commission (NMC). New Delhi, in criminal conspiracy with intermediaries and representatives of various private medical colleges across the country, are engaged in acts of corruption, abuse of official position, and wilful misconduct.

These individuals have allegedly facilitated unauthorized access to, and unlawful duplication and dissemination of, confidential files and sensitive information pertaining to the regulatory status and internal processing of medical colleges within the Ministry. Furthermore, they have been involved in manipulating the statutory inspection process conducted by the NMC by preemptively disclosing the inspection schedules and identities of the designated assessors to the concerned medical institutions, well in advance of the official communication.

Such prior disclosures have enabled the medical colleges to orehestrate fraudulent arrangements, including the bribing of assessors to secure favourable inspection reports, the deployment of non-existent or proxy faculty ("ghost faculty"), and the admission of fictitious patients to artificially project compliance during inspections, and tampering with the biometric attendance systems to falsify faculty presence records.

These acts, committed in exchange for monetary and other illicit considerations undermine the integrity of the regulatory framework and jeopardize the quality of medical education and public health standards in the country.

The source has also informed that a group of individuals, namely Ms. Poonam Meena, Sh. Dharamvir, Sh. Piyush Malyan (Section Officer), Sh. Anup



Jaiswal, Sh. Rahul Srivastava, and Sh. Chandan Kumar all officials associated with the Ministry of Health and Family Welfare, Government of India are involved in unauthorized and unlawful dissemination of sensitive and classified information related to the inspection, renewal, and issuance of Letters of Approval (LoA) for various medical colleges in exchange for bribe.

These individuals are misusing their official access by locating and tracking relevant files within the Ministry and illicitly capturing photographs of internal noting and comments made by senior ministry officials. These images are then being shared through personal mobile devices with private individuals and representatives of medical colleges, thereby violating official secrecy protocols and compromising the integrity of the regulatory process.

The recipients of such confidential information include, but are not limited to, Dr. Virendra Kumar (resident of Palam Vihar, Gurugram, Haryana). Ms. Manisha Joshi (Sector-8. Dwarka. New Delhi). Sh. Suresh Singh Bhadoria (Chairman, Index Medical College, Indore), Sh. Udit Narain (Panki, Kanpur), Dr. Joshy Mathew (Green Park Extension, New Delhi). and Sh. Mayur Raval (Registrar, Geetanjali University, Udaipur, Rajasthan).

The source has also informed that Dr. Virendra Kumar, through one Shri Indra Bali Mishra alias 'Guruji', resident of AN-315/1, Ganga Pradushan Road, Bhagawanpur, BHU, Varanasi, Uttar Pradesh, was in touch with Dr. Jitu Lal Meena, the then Whole-Time Member of the Medical Assessment and Rating Board (MARB). They, in criminal conspiracy with each other, extorted substantial amounts of illegal gratification from various private medical colleges in exchange for granting them undue regulatory favours. The bribe amounts were routed to Dr. Virendra Kumar in Delhi through Hawala channels. On multiple occasions, Shri Shivam Pandey, resident of Noida, under the instructions of his brother-in-law Shri



Indra Bali Mishra collected bribe amounts from Dr. Virendra Kumar and delivered the same to Dr. Jitu Lal Meena at his residential premises.

The source has also informed that Dr. Jitu Lal Meena has been constructing a Hanuman Temple at Mohcha Ka Pura, Sawai Madhopur, Rajasthan, through his ill-gotten money and the construction cost (approx. Rs. 75 Lakhs) has been paid to the contractor Shri Bhikalal r/o Dausa, Rajasthan, through hawala channel out of the collected bribe money by Dr. Virendra Kumar on behalf of Dr Jitu Lal Meena.

The source has further revealed that Dr. Virendra Kumar operates in the southern states of India through his associate, Dr. B. Hari Prasad, a resident of Kadiri. Andhra Pradesh. Dr. Hari Prasad is assisted by two partners, Dr. Ankam Rambabu, residing at Penthouse, Park View GS Apartments, Near Srinagar Park, Srinagar Colony, Hyderabad, and Dr. Krishna Kishore, residing at D. No. 49-11-5, Lalitha Nagar, Akkayyapalem, Visakhapatnam.

Dr. B. Hari Prasad, while posing as a consultant to medical colleges, is engaged in unlawful activities such as arranging dummy faculty members for statutory inspections and facilitating the issuance of Letters of Renewal and other regulatory approvals from authorities, including the National Medical Commission (NMC), in exchange for bribe money.

The source has further revealed that in one instance, Dr. Krishna Kishore, acting on the directions of Dr. Hari Prasad, had collected ₹50 lakhs from Shri Venkat, Director of Gayatri Medical College, Visakhapatnam, to ensure favourable resolution of a matter pending before the NMC. A portion of the said bribe amount was subsequently transferred to Dr. Virendra Kumar in Delhi via hawala channels.

The source has further revealed that Dr. Hari Prasad and Dr. Ankam Rambabu jointly managed the regulatory affairs of Father Colombo Institute of Medical Sciences, Warangal. In return, Fr. Joseph Kommareddy of the said



institute had paid ₹20 lakhs and ₹46 lakhs on two separate occasions. These payments were routed to Dr. Hari Prasad through intermediaries via formal banking channels.

The source has further revealed that Ms. Poonam Meena, Director MoHFW had has asked Sh. Piyush Malyan, SO to ascertain information from NMC regarding inspection date of a Medical College in advance and also asked to tell her about the expenses for disclosing the information. Piyush agreed and asked her to share the details of college with him.

The source has further revealed that Shri Chandan Kumar of the Ministry of Health has been sharing confidential information with Shri Suresh Singh Bhadoria, Chairman of the Index Group of Institutions, Indore, Madhya Pradesh. The Index Group comprises institutions offering education in Medicine, Dentistry, Nursing, Pharmacy. Paramedical Sciences, and Management, all affiliated with Malwanehal University since the academic year 2015–16. Shri Bhadoria is also Chairman of Mayank Welfare Society, the parent body operating Malwanehal University.

Furthermore, Index Medical College, Hospital & Research Centre, Indore had employed doctors and staff on a temporary basis but falsely recorded them as permanent faculty to meet the National Medical Commission's Minimum Standard Requirements (MSR). The institution is also allegedly involved in fabricating artificial clone finger impressions of these individuals to manipulate biometric attendance under the Aadhaar Enabled Biometric Attendance System (AEBAS).

The source has also disclosed that Shri Bhadoria, with the assistance of close aides, is orchestrating a wide range of illegal activities through Malwanehal University and its affiliated institutions. These activities include issuing fraudulent Undergraduate, Postgraduate, and Ph.D. degrees to ineligible candidates, often

backdated, fabricating professional experience certificates, mark sheets, theses, and manipulating biometric records using cloned fingerprints.

The source has further disclosed that Shri Chandan Kumar has been illicitly disseminating confidential information to Shri Mayur Raval. Registrar. Geetanjali University. Udaipur. Rajasthan. presently residing at RH No. 9, Ashok Astoria, Gangapur Road, Gangapur Gaon, Near Govardhan Village, Nashik, Maharashtra.

The source has further disclosed that Shri Mayur Raval, in criminal conspiracy with Shri R. Randeep Nair. Project Head, M/s Techinfy Solution Pvt. Ltd. (resident of New Delhi) and unidentified officials of the National Medical Commission (NMC), is actively engaged in corrupt practices involving the solicitation and receipt of illegal gratification from various medical colleges. In exchange, they have extended undue favours, including the unauthorized sharing of sensitive and advance information pertaining to scheduled physical inspections by NMC assessor teams.

The source has further disclosed that Shri Nair, exploiting his access and in collusion with accomplices, has been approaching medical colleges like Swaminarayan Institute of Medical Sciences & Research (SIMSR), Kalol, Gujarat. National Capital Region Institute of Medical Sciences. Meerut. U.P. Shyamlal Chandrashekhar Medical College, Khagaria, Bihar and others and has been assuring their representatives of prior intimation of inspection team details and inspection dates. This enables such colleges to fabricate compliance, including by arranging proxy or ghost faculty, thereby subverting the inspection process. Substantial bribes have been demanded and received in this regard for personal gain and for the benefit of other unknown public officials.

The source has further disclosed that Shri Rawatpura Sarkar Institute of Medical Sciences and Research (SRIMSR). Raipur. Chhattisgarh, at the behest of



its Chairman, Shri Ravi Shankar Ji Maharaj, was involved in a conspiracy to obtain confidential and advance information regarding a forthcoming official inspection. Shri Atul Kumar Tiwari, acting in collusion with Shri Raval, sought to procure such privileged information unlawfully. It is further disclosed that Shri Ravi Shankar Ji Maharaj also sought the help of Sh. D.P. Singh, Chancellor of Tata Institute of Social Studies. Mumbai (TISS) to persuade the members of Inspection team to give favourable report in lieu of bribe, who further delegated this task to one Suresh.

The source has further revealed that Shri Raval demanded an illegal gratification of ₹25-30 lakhs in exchange for disclosing confidential inspection-related details. On 26th June 2025, Shri Raval had informed Shri Tiwari to make preparations for the inspection scheduled on 30th June 2025 (Monday). Furthermore, Shri Raval also divulged the names of the designated inspection team members to Shri Tiwari, thereby breaching official confidentiality and violating statutory provisions governing such inspections.

The source has further revealed that inspection team consisting of 4 assessors designated by NMC, as informed by Shri Mayur Raval, reached for inspection at SRIMSR, Raipur on 30th June 2025. All the 04 members of inspection team have entered into conspiracy with Sh. Atul Kumar Tiwari of SRIMSR and agreed to take bribe for issuing a favourable inspection report. One of the members of inspection team, Dr. Manjappa CN, Professor and HOD (Orthopaedics), Mandya Institute of Medical Sciences, Bangalore-Mysuru Main Road, Mandya, Karnataka, instructed Dr. Satish of Bangalore to collect Rs. 55 lakhs from a Hawala operator. He also told Dr. Satish that he would receive a call from Hawala operator as to how the amount has to be collected. Dr. Manjappa also talked to Dr. Chaitra, another member of the inspection team and told her that her share would be delivered by Dr. Satish at her residence or someone can collect it from Dr. Satish. This bribe transaction is likely to happen today itself.

The above acts constitute offences punishable u/s 61 (2) of BNS, 2023 and section 7, 8, 9, 10 and 12 of Prevention of Corruption Act, 1988 (as amended in 2018) by Shri Mayur Raval, Registrar, Geetanjali University, Udaipur, Rajasthan, Shri R. Randeep Nair, Project Head, M/s Techinfy Solution Pvt. Ltd., Shri Rawatpura Sarkar Institute of Medical Sciences and Research (SRIMSR), Raipur, Chhattisgarh, Shri Ravi Shankar Ji Maharaj, Chairman, Shri Rawatpura Sarkar Institute of Medical Sciences and Research (SRIMSR), Raipur, Chhattisgarh, Shri Atul Kumar Tiwari, Director, Shri Rawatpura Sarkar Institute of Medical Sciences & Research, Nava Raipur, Chhattisgarh, Sh.
